- Bid will be opened in the presence of the bidders' representatives who choosed to allained at 13:00 hours on 02th Jan, 2022 (18 Push, 2078 B.S.). for all contracts at the office of Dhangadhimai Municipality Dhangadhi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the bid validity period. The original bid bond guarantee letter should be issued in the name of the office by any Commercial (Banijya) Bank, recognized by Govt. of Nepal. Only the bid security guarantee letter in the format specified in the bid document will be accepted or bidder who choose to deposit the bid security in cash shall deposit the cash and submit receipt the voucher from the Bank listed above.
