Bidder's submitting their bid electronically following procedure specified in e-GP system operating guideline ,2073 and user manual issued by PPMO, should deposit the cost (pdf format) of the document in the project's rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Also submission of signed letter of bid, along with the copy of company/firm registration certificate, business registration (License) and renew certificate, VAT and PAN registration certificate, Tax clearance certificate up to F/Y 2077/78 and the time of extension in the case of previous F/Y clearance is compulsory. Bid will be opened in the presence of the bidders' representatives who choosed to allained at 13:00 hours on 26th Jan, 2022 (12 Magh, 2078 B.S.). for all contracts at the office of Dhangadhimai Municipality Dhangadhi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the bid validity period. The original bid bond guarantee letter should be issued in the name of the office by any Commercial (Banijya) Bank, recognized by Govt. of Nepal. Only the bid security guarantee letter in the format specified in the bid document will be accepted or bidder who choose to deposit the bid security in cash shall deposit the cash and submit receipt the voucher from the Bank listed above.
